

Oliver Accountancy Ltd DATA PROTECTION AND PRIVACY Policy

This policy applies to the Oliver Accountancy Ltd in England.

We are committed to ensuring that your privacy is protected, and we strictly adhere to the provisions of the Data Protection Act 1998 and the Privacy and Electronic Communications (EC Directive) Regulations 2003 and will compliant with the EU General Data Protection Regulation (GDPR), which comes into force on the 25th May 2018.

Our Privacy Policy, together with our terms and conditions, sets out how we collect personal information from you, or how you provide us with personal information, which will be processed by us.

Controlling your personal information

At Oliver Accountancy, we take your privacy seriously and comply with the Data Protection Bill, 25 May 2018.

We ensure that we hold only details that each customer has authorised Sauté to hold, for specific purposes that have been defined to each customer.

We do not hold any credit card details on site. Once payment is taken, all credit card details are destroyed and are no longer accessible to any staff member or our credit card processor.

WHAT WE COLLECT

When someone visits our website we collect standard Internet log information and details of visitor behaviour patterns. We do this to find out things such as the number of visitors to the various parts of the site. We collect this information in a way that does not identify anyone. We do not make any attempt to find out the identities of those visiting our website using the data in the logs. We will not associate any



log data gathered from this site with any personally identifying information from any source.

Comment and Enquiry Forms

Our website allows visitors to contact us via an enquiry form. We collect the following information: Name, contact number, Email and Enquiry Message. We require this information to improve our services and be able to respond to visitor enquiries.

Cookies

Cookies are small text files that are placed on your computer by websites that you visit. They are widely used in order to make websites work, or work more efficiently, as well as to provide information to the owners of the site. Cookies that are used by this website are necessary in order for us to improve our website for all the users. Cookies are not shared with any third parties.

The following cookies will be set.

Google Analytics: We use Google Analytics to monitor and report on our website usage such as the number of visitors to the site, search phrases used to find us, pages visited on the site and time spent on the site. The statistics gathered are a necessary requirement in order for us to provide and improve our services and to stay competitive. The cookies do not identify users nor associate your IP address with any personally identifiable information.

These cookies are used to collect information about how visitors use our site. We use the information to compile reports and to help us improve the site. The cookies collect information in an anonymous form, including the number of visitors to the site, where visitors have come to the site from and the pages they visited.

You may request in writing that Oliver Accountancy disclose details of data which it holds about you and the purpose for which such data is held. A 'Subject Access Request Form' will be supplied upon request. We'll need your passport or driver's licence for proof of identity.

If we do hold information about you, we'll:

- give you a description of the categories of personal data;
- tell you why we are holding/processing it;
- tell you who it has and or might be disclosed to; and
- let you have a copy of the information in an intelligible form.

If we hold incorrect information about you, you can ask us to correct any mistakes by contacting the Data Protection Officer. We'll use reasonable efforts consistent with our legal duty to supply, correct or delete personal information about you on our files.

Right of rectification:

- you object to the processing of data for direct marketing purposes; and
- we have unlawfully processed your personal data.
